2019: Nancy & Amy Decaron, founders of Hope of Mooresville (HOMe), which serves as the only temporary housing facility for women and children experiencing homelessness in Mooresville.

2018: Erin Santos, executive director of the Isabella Santos Foundation, because of the tremendous contribution that her foundation has made locally and nationally to raise awareness and funding for research and a cure to neuroblastoma, a rare and aggressive form of childhood cancer.

2017: Shaun "Lucky" Corbett, owner and principal barber of Da Lucky Spot Barbershop, for his work with the "Cops & Barbers" initiative that increases dialogue and creates relationships between the community and police departments.

2016: Don Gately, executive director of the CrossRoads Corporation for Affordable Housing and Community Development, where he has led the formation of multiple projects that have helped to elevate the quality of life in the Grier Heights Community.

2015: John Crawford, who established the Charlotte Housing Authority Scholarship fund.

2014: Otis Crowder, co-owner of Crowder Construction, whose philanthropic giving, passion and service have impacted many organizations in the community.

2013: Curt Seifart, a key volunteer, advocate and resource for the CrossRoads Corporation as they continue their work in Grier Heights.

2012: Bob Bishop, an advocate for the local homeless community, who raises funds and awareness for those who struggle to survive on a daily basis.

2011: Ginger Dowdle, founder and benefactor of The Shepherd's Watch, an organization that includes a summer camp devoted to children who age out of the foster care system.
