- Billed 7,797 CarolinaMLS Subscribers for 1Q 2013: 495 Assistants, 5,246 Subscribers and 2,056 Member Participants. This compares to a total of 7,782 for 4Q 2012: 460 Assistants, 5,271 Subscribers and 2,051 Member Participants. This is an increase of 0.19% from 4Q 2012 to 1Q 2013.
- Billed 6,318 Supra keyholders for 1Q 2013 compared to 6,312 for 4Q 2012. This is a decrease of 0.095% from 4Q 2012 to 1Q 2013.
- Member Services and Accounting received an average of 1,735 queue phone calls per month for 4Q: 1,474 for October; 1,571 for November; and 2,160 for December.
