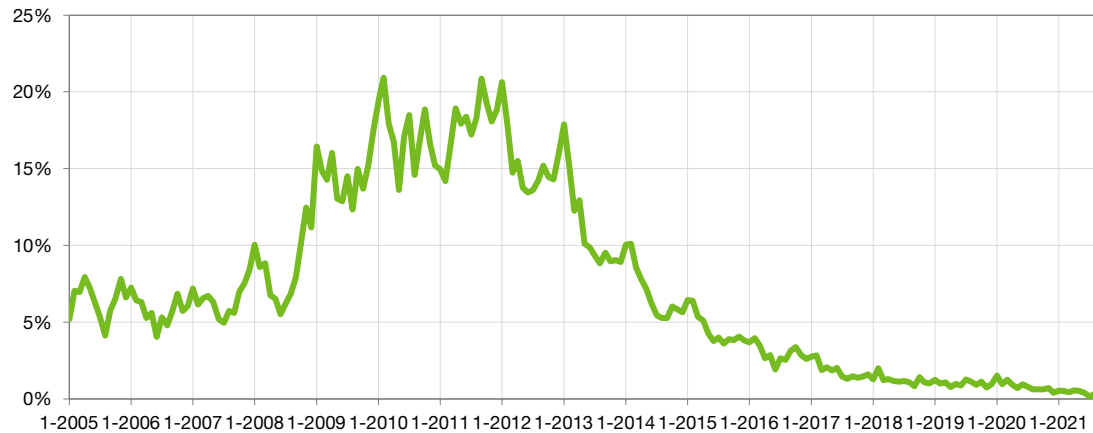

Share of Closed Sales That Were Lender-Mediated: 0.3%

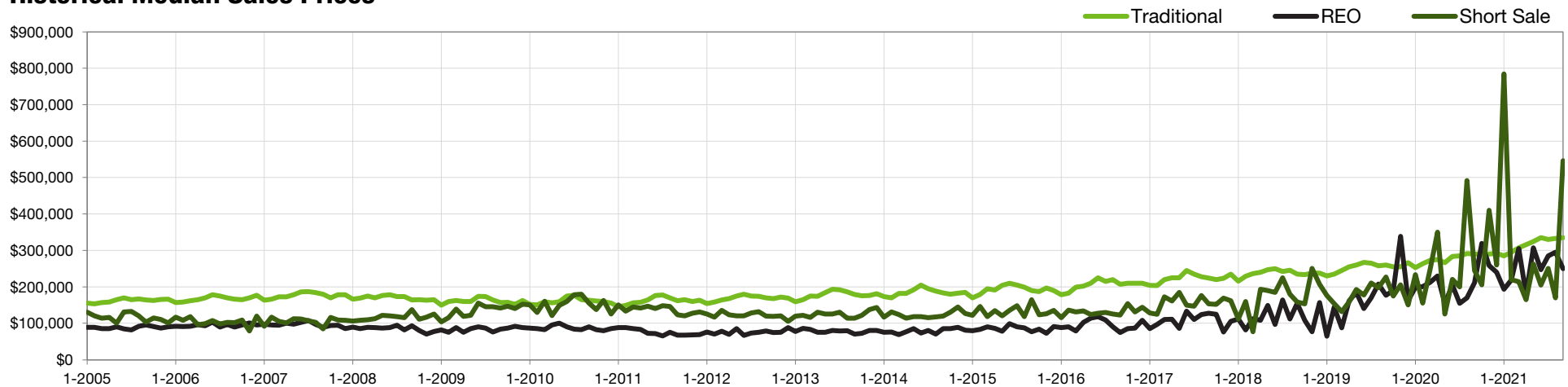
