**MEMBERS-ONLY FORUM TERMS OF USE**

General

The Charlotte Regional REALTOR® Association, Inc. (the “Association”) Members-Only Forum (the “Forum”) is furnished to the Members of the Association by, and at the sole discretion of, the Association. Your acceptance of and compliance with the following terms, as well as the Website Terms of Use located on the Association’s website [www.CarolinaRealtors.com](http://www.CarolinaRealtors.com) (which are incorporated herein by reference as if fully set forth herein, the terms of which, together with the terms herein, are collectively referred to herein as the “Terms”), is required as a condition of your use of the Forum.
